

## What is this Promotion about?

Revolut is offering prospective Revolut Pro customers residing in United Kingdom, Romania, Ireland, France, Spain, Portugal, Lithuania, Italy, Germany, Hungary, Greece, Bulgaria, Czechia, the Netherlands, Sweden, Cyprus, Latvia, Belgium, Slovakia, Denmark, Norway, Austria, Estonia, Slovenia and Finland (together, the **"Eligible Markets"**) the **opportunity to open a Revolut Pro account and receive a "Cash Award", upon spending the required amount using their Revolut Pro card**, as listed below:

These terms and conditions and the information included in the Promotion communication (the **"Promotion Terms"**) set out the rules that apply to the Promotion, and you must comply with these Promotion Terms, the Personal terms that apply to your Revolut Personal and the Revolut Pro account Terms that apply to your Revolut Pro account at all times when participating in the Promotion.

To participate in this Promotion, you must meet the eligibility criteria and complete the required steps outlined in these Promotion Terms between **23 June 2025 (00:00 UTC) and 22 July 2025 (23:59 UTC)** (the **"Promotion Period"**).

## Who is eligible for this Promotion?

To be considered an **"Eligible Participant"** for this Promotion you **must** meet the following **"Eligibility Criteria"**:

- Have a residential address in one of the Eligible Markets;
- Receive an email, push notification and/or in-app Inbox message from Revolut inviting you to participate in this Promotion (the “Promotion Invitation”); and
- Not currently hold, and have never previously held, a Revolut Pro account with any Revolut group entity.

You will also need to complete the “**Required Steps**” before the end of the Promotion Period:

- **Successfully open a Revolut Pro account during the Promotion Period;**
- **Make card payments totaling Required amount using your Revolut Pro card within the Promotion Period,** depending on the Promotion Invitation each client has received.

Your card payments can be made using a physical or virtual Revolut card linked to your Revolut Pro account. They must be genuine purchases (for example, transactions to payment service providers, other bank accounts and e-wallets will not be genuine).

## How do I get my Cash Award?

The Cash Award will be credited to your Revolut Personal account within 10 business days after the end of the Promotion Period.

## What other legal information should I know?

1. We may change, suspend or end the Promotion earlier than the end date we’ve mentioned above if the Promotion is being abused or may negatively affect Revolut’s goodwill or reputation, or due to reasonably unforeseeable and external circumstances which may make it impossible for us to continue running this Promotion. We may do this on an individual or promotion-wide basis.
2. If we need to change, suspend or end the Promotion before the end of the Promotion Period, we will announce this in the same way the Promotion was announced and, where possible, we will give you notice through email, push and inbox. Any changes to the Promotion Terms will not affect your rights, if you have already participated in the Promotion.
3. Revolut will not be liable for any loss, whether directly or indirectly suffered, as a result of a reasonably unforeseeable event outside of its control which means we are unable to continue running the Promotion as planned. Please contact Support if you believe you qualify for a particular benefit in relation to the Promotion that has not been awarded to you as a result of early suspension or termination.

4. We reserve the right to reverse the Cash Award during the Promotion Period if the payment that earned you the Cash Award is refunded to you, you earned the Cash Award fraudulently, if you breach the terms that apply to your Revolut Personal account in order to get the Cash Award, or if we become aware you did not comply with these Promotion Terms. We will consider the reversal of any Cash Award to have been done with your consent and the payment to have been authorised by you.
5. If you close your Revolut Personal account or your account becomes suspended or restricted before we are due to credit your account with the Cash Award or between the time of qualifying for the Cash Award and receiving it, you will lose your entitlement to the Cash Award.

The English language version of these terms shall apply and prevail and be conclusive and binding. The English version shall be used in any legal proceedings. If, however, by law the local language should be used, the local language will prevail over the English version and will be used in legal proceedings (please refer to the below table to determine whether another language prevails and will be used in legal proceedings).
