### What is this promotion about?

- You must live in the UK or EEA (except Liechtenstein, Malta and Cyprus).

### How do I earn my Reward?

Despite this, you can still rely on the mandatory consumer protection rules of the EEA country where you live. Any disputes arising out of or in connection with these Incentive Terms shall exclusively be submitted to and dealt with by the competent court in the Republic of Lithuania (or in the courts of any EU Member State where you reside).
