

TERMS AND CONDITIONS OF THE "3 MONTHS OF CHATGPT GO FOR FREE" PROMOTION

These terms and conditions of the Promotion (the "Terms") set forth the rules applicable to this Promotion as defined below.

What is this Promotion about?

1. **What:** The opportunity to receive a three (3) month free trial of the ChatGPT Go subscription plan (the "**Free Trial**"), subject to these Terms.
2. **Who:** Revolut individual customers with a **Standard** or **Plus** Plan (once the latter becomes available), who reside in Mexico (the "**Market**") and who have completed the Required Step described below before the end of the Promotion Period.
3. **When:** The Promotion begins on July 30, 2026 (00:00 UTC) and will remain in effect indefinitely, until Revolut terminates it (the "**Promotion Period**"). To participate, you must accept the Promotion during the Promotion Period. Once accepted, you will have three (3) months and one (1) day to complete the Required Step.

Important Note: *At the end of the Free Trial, your ChatGPT Go subscription plan will automatically renew at the standard monthly rate, and OpenAI OpCo, LLC (the "Partner") will charge you accordingly. To avoid unwanted charges, you must cancel your subscription directly with the Partner at least twenty-four (24) hours before the billing date at the end of the Free Trial.*

Eligibility

To be eligible for this Promotion, you must:

1. have a registered address on the Marketplace;
2. not have an active ChatGPT subscription and not have been a ChatGPT subscriber at any time during the previous three (3) months;
3. be at least 18 years of age; and
4. have a Revolut **Standard** or **Plus** subscription plan (once the latter becomes available).

Required Step

To get the Free Trial, you must follow the *deep* link for the Promotion. Revolut will share this link through one of the following communication channels: email, push notification, a banner within the Revolut App, or a message in the Revolut App inbox (the "Communication").

The *deep link* will redirect you to a specific promotional page within the Revolut app and then to the ChatGPT redemption flow. To redeem your ChatGPT Go Free Trial, follow the instructions displayed within the app.

Important: If you do not sign up for the Free Trial through the deep link in the message, you will not be able to get the Free Trial.

How do I start my ChatGPT Go Free Trial?

You can only complete the Required Step within the Promotion Period to claim your three (3)-month Free Trial of ChatGPT Go.

Once you click "**Claim Offer**" (or equivalent text) in the relevant Communication, you'll be redirected via a *deep* link to the ChatGPT redemption flow within the Revolut app. Next, when you click "**Go to ChatGPT**" (or equivalent text), you'll be redirected to the ChatGPT website, where you'll need to create a new ChatGPT account or log in to your existing account. Your promo code will be automatically applied at checkout.

If, for any reason, your promo code is not recognized at the time of purchase or the price displayed is not as expected, do not complete the purchase and contact the Partner's customer service with screenshots and the relevant details via support@openai.com or through their help center.

The Free Trial will not be available if, at the time of redeeming the Revolut promo code, you have an active ChatGPT subscription or if you have had a ChatGPT subscription at any time during the previous three (3) months.

By registering on the Partner's website, you will enter into a separate service agreement with the Partner, subject to its own terms and conditions. Be sure to read those terms, as well as the information regarding charges that may apply to your ChatGPT Go account once the Free Trial period ends.

What happens when the Free Trial ends?

At the end of your three (3) month ChatGPT Go Free Trial, it will automatically convert to a paid ChatGPT Go subscription at the Partner's standard monthly rate. The corresponding charges will be billed directly by the Partner.

If you do not want to be charged at the end of your Free Trial, you must cancel your subscription through your account with the Partner at least twenty-four (24) hours before your first billing date.

Changes to Your Revolut Subscription Plan

1. If you change your Revolut Plan during the Promotion period, such a change will not affect the three (3) month ChatGPT Go Free Trial that you have already validly redeemed, subject to the Partner's terms and conditions.
2. If you upgrade or downgrade your Revolut Plan between **Standard** and **Plus** (once the latter becomes available), you will retain the right to redeem or keep the Free Trial, provided you meet all other eligibility requirements.
3. If you have a Standard or Plus Plan and upgrade your Revolut Plan to **Premium**, **Metal**, or **Ultra**, in addition to keeping the Free Trial from this promotion, you'll be able to unlock the standard paid plan benefit for ChatGPT corresponding to your new Revolut Plan, as follows:
 - (a) **Premium** Plan: six (6) months of access to the corresponding standard benefit; and
 - (b) **Metal** and **Ultra** Plans: twelve (12) months of access to the corresponding standard benefit.
4. The standard paid plan benefit for ChatGPT associated with Premium, Metal, or Ultra plans is separate from this Promotion and may be subject to additional terms and conditions, eligibility requirements, validity periods, restrictions, and redemption mechanisms. Upgrading to Premium, Metal, or Ultra plans does not automatically extend the three (3)-month free period of this Promotion.

Revolut's participation is limited to communicating the offer to eligible customers and facilitating initial access to the redemption flow through the Revolut app.
Abuse or Misuse of the Promotion	We may suspend, modify, or terminate the Promotion if there are reasonable grounds to believe it is being abused, or if reasonably unforeseeable circumstances beyond our control arise that make it impossible to continue the Promotion. Changes or Early Termination	If we need to modify, suspend, or terminate the Promotion before it ends, we'll notify you via email and push notification. Fraud or Violation of Rules	We may not allow you to participate in this Promotion if: you did not successfully complete the Required Step; you commit fraud or materially abuse this Promotion (for example, by attempting to gain an unfair advantage through deception or by providing false information); or you breach these Promotion Terms or the terms and conditions of Revolut's Plans and/or your Revolut Account agreement, and such breach directly affected the granting of
