# Terms and Conditions

Welcome to the Paid Plan First Month Fee Waiver Promotion (the "**Promotion**"), offered by Revolut Payments Australia Pty Ltd (ABN 21 634 823 180) ("**Revolut**", "**we**", "**our**" or "**us**").

The terms and conditions of the Promotion are set out below. These terms and conditions apply in addition to the other terms and conditions that apply to you as a customer of Revolut, including the Personal Terms, Fees and Charges Section and the Premium and Metal Terms.

# **Promotion Period**

The Promotion starts on 16 December 2022 12:00am GMT (11am AEDT) and ends on 13 June 2024 11:59pm GMT (14 June 2024 9:59am AEST) (the "**Promotion Period**").

## What is the Promotion?

The Promotion is an opportunity for Eligible Customers to have the first month of their Revolut Premium or Revolut Metal monthly subscription fees waived:

- For new Premium users: sign up to the Premium Plan during the Promotion Period and have your the subscription fee waived for the first month (the "Premium Plan Fee Waiver Offer"); or
- For new Metal users: sign up to the Metal Plan during the Promotion Period and have the subscription fee waived for the first month (the "Metal Plan Fee Waiver Offer" and together with the "Premium Plan Fee Waiver Offer", the "Fee Waiver Offer").

The Revolut Premium and Revolut Metal subscription plans have a contract term of 12 months. This means that after the Fee Waiver Offer period, you will have to pay the normal subscription fee as set out in the Subscription Fees Table below for the remaining 11 months.

Please refer to the Fees and Charges Section for more information on costs associated with the Revolut Premium and Revolut Metal subscription plans.

## Who is eligible to participate in the Promotion?

In order to participate in the Promotion you must be an Eligible Customer of Revolut. An "**Eligible Customer**" is defined as a customer that during the Promotion Period has:

- personally received communications from Revolut inviting you to participate in the Promotion,
- passed Revolut's 'Know Your Customer' checks and been onboarded;
- an active Revolut Standard or Premium account, and
- not previously closed a Revolut account or had an account become suspended or restricted.

# How do I claim my Fee Waiver Offer?

Eligible Customers will receive an in-app notification containing the Fee Waiver Offer. The notification will include instructions on how to upgrade your Revolut account.

Eligible Customers will have **72 hours to claim of the Fee Waiver Offer** after receiving the in-app notification, even if the 72 hour period expires after the end of the Promotion Period.

# What happens if I cancel my paid subscription after claiming my Fee Waiver Offer?

If you cancel or downgrade your plan after claiming the Fee Waiver Offer, the fees set out in the Cancellation Fees Table below will apply.

Please be aware that if you order a Revolut Card during your Fee Waiver Offer period and then cancel your subscription plan before your Fee Waiver Offer period ends, you will be charged card fees. For this reason, **we recommend only ordering a Revolut Card after you decide to keep the plan for the full 12 month term.** 

Further, we won't refund amounts already paid. For example, if you order additional Revolut Cards beyond your plan's card allowance you will not receive a refund.

After the Fee Waiver Offer period ends, by default you will remain on the Revolut Premium or Revolut Metal subscription plan (payable monthly) unless you tell us otherwise, and normal subscription fees set out in the Subscription Fees Table below will apply.
