

What is this Promotion about?

- **Who:** Existing Revolut Metal and Ultra Personal customers residing in the United Kingdom, Germany, France and Spain (the **Markets**), who received an email, push or an in-app invitation to participate in this promotion (each a **Promotion Invitation**) and complete the required steps below.
- **When:** The promotion will be available from **1 January 2026 (00:00 UTC)** to **30 June 2026 (23:59 UTC)** (the **Promotion Period**).
