

2025 Revolut Dutch Influencer Raffle promotion

What is this promotion about?

As part of the Revolut Dutch Influencer Raffle promotion (the "**Promotion**"), Revolut offers potential Personal customers residing in the Netherlands the opportunity to take advantage of a special promotion:

- receive EUR 20 credited to their newly opened Revolut Personal account (the "**Welcome bonus**"); and
- enter one of the prize draws for a chance to win EUR 1,000 (the "**Prize**").

These general terms and conditions (the "**Promotional terms and conditions**") set out the rules applicable to this Promotion and you must comply with these Promotion Terms and Conditions as well as the [Personal Terms and Conditions](#) which will apply to your new Revolut Personal account at all times when you participate in this Promotion.

Please note: the 2025 Revolut Dutch Influencer Raffle Promotion is different from other Revolut promotions that can run simultaneously and also includes social media influencers.

This Promotion consists of multiple draws throughout 2025. The maximum prize pool for the Promotion is EUR 20.000, and the Promotion has a maximum of 20 draws, each with one winner entitled to a prize of EUR 1.000 (the "**Prize**").

Each draw is linked to an influencer campaign in the Netherlands. Every influencer campaign has a fixed start and end date. The influencer campaigns can sometimes overlap. You can distinguish draws based on the end date of the promotion, which are unique.

Each new customer can only benefit from the Welcome bonus once. However, once the customer has successfully registered, they will automatically be eligible to participate in all 2025 draws for the Prize, under this Promotion. To participate in this Promotion, you must meet the eligibility criteria on an ongoing basis and before and during the "Promotion period" complete the required steps set out in these Promotion Terms and Conditions. These Promotion Terms and Conditions have also been

communicated by the influencer on their social media platform and on the relevant related landing page.

Who is eligible for this promotion?

To be considered an **“eligible participant”** for this Promotion you must comply with the next **“Eligibility Criteria”**:

- have a residential address in the Netherlands;
- do not have or have previously had a Revolut Personal account with a Revolut group entity; and
- be at least 18 years old.

You also need to use the **“Required steps”** completed before the end of the Promotion Period:

- **click on the unique Promotion link** – this will be provided by the influencer within the content or video description;
- **successfully open a Personal account with Revolut** for the first time via the unique promotional link; and
- **perform a first processed card transaction** of at least € 0,01 (or currency-equivalent).

You must use the unique Promotion link provided as part of this promotion to sign up for a Personal account with Revolut. If you sign up through the normal account opening process through our app, you will not be able to participate in this promotion. Your first card payment can be made with a physical or virtual Revolut card linked to your Personal Revolut account. It must be a real purchase (for example, transactions to payment service providers, other bank accounts and e-wallets will not be approved).

How do I earn the Welcome Bonus?

If you are an eligible participant, the Revolut group entity that provides you with your personal account will credit the Welcome Bonus to the main balance of your Revolut Personal account within 30 days of you completing the required steps.

How do I participate in the Prize draw?

Within 30 days after the end of the promotional period, we will enter the Revolut usernames of all eligible entrants into the prize draw and randomly select one eligible entrant as the winner. This process will take place in 2025 for a maximum of 20 draws.

If you are the winner, we will notify you by email (to the email address registered in your Personal account). We will also announce the winner on the corresponding landing page. Once you have won the prize draw, you will be excluded from further participation in future prize draws under this promotion for 2025.

If we contact you to let you know that you have won, but within 30 days of contacting you we realize that you no longer meet the criteria to be considered an eligible entrant, we will not be able to award you the prize and will select another eligible entrant at random. You will also no longer be eligible to participate in any future draws of the Promotion until you meet the criteria to be considered an eligible entrant.

Our decisions regarding the conduct and administration of the Promotion, including the selection of the winner, are final and binding.

What other legal information do I need to know?

1. We hereby confirm that this Promotion is in accordance with the [Dutch Code of Conduct for promotional games of chance](#).
2. We may vary, suspend or end the Promotion earlier than the end date stated above if, in our reasonable opinion, the Promotion is being misused or may adversely affect the goodwill or reputation of Revolut. We can do this on an individual basis or on a Promotion-wide basis.
3. If we need to change, suspend or end the Promotion before the end of the Promotion period, we will announce this in the same way the Promotion was announced and where possible we will try to notify you via the app and/or email. Revolut will not be liable for any loss, whether suffered directly or indirectly, as a result of any event beyond its control which prevents us from continuing to run the Promotion as planned. Please contact customer service if you believe you may be eligible for a particular benefit related to the Promotion that has not been awarded to you as a result of an early suspension or termination. Any changes to the Promotion terms and conditions will not affect your rights if you have already entered the Promotion.

4. Employees, directors, agents, contractors and any subsidiaries of any Revolut group or entities and the same individuals associated with any of the social media influencers with whom this promotion is associated are not eligible to enter this Promotion.
5. These Promotion Terms and Conditions are published in Dutch. If they are translated into another language, the translation is for reference only and the Dutch language version of the Promotion terms and conditions shall prevail. In any legal proceedings, the Dutch version of these Promotion terms and conditions will be used.
6. If you have a complaint about this Promotion, please contact us via app. We will investigate your complaint and try to resolve matters via email as quickly as possible.
7. If you are not satisfied with the way in which we have handled your complaint, you can still submit your complaint to the Dutch Gaming Authority. You can reach the Gaming Authority via the following email address: info@kansspelautoriteit.nl.
8. In accordance with Dutch tax regulations for promotional gambling, Revolut is legally required to withhold tax from the Prize on behalf of the winners. The gambling tax rate is from January 1, 2025 34,20%. The gross prize of the winner is € 1.519,75. However, after deduction of the gambling tax, the net prize is: € 1.000,00.
