Revolut - Kids & Teens Terms and Conditions

Version dated June 24, 2025

1. Why is this information important?

This document sets out the terms and conditions for the use of Revolut – Kids & Teens (the "Revolut – Kids & Teens Terms"), and other important things that you need to know about it.

To set up Revolut – Kids & Teens, you must have a Revolut personal account. These Revolut – Kids & Teens Terms apply in addition to our Personal Terms and the Cardholder Agreement when you choose to use Revolut – Kids & Teens. If there is any inconsistency between the Personal Terms and the Revolut – Kids & Teens Terms, these Revolut – Kids & Teens Terms shall apply.

If you do choose to use Revolut – Kids & Teens, these Revolut – Kids & Teens Terms will form part of the legal agreement between you (the account holder) and us (Revolut Technologies Inc.). There is no legal agreement between us and any child between the ages of 6 and 17 you sign up for Revolut – Kids & Teens (each, a "Revolut – Kids & Teens User").

In these Revolut - Kids & Teens Terms:

- The 'Revolut Kids & Teens account' means a sub-account of your Revolut personal account to which you grant access to a Revolut – Kids & Teens User.
- The 'Revolut app' means the Revolut app that you use to access your personal account. The 'Revolut Kids & Teens app' means the app that Revolut Kids & Teens Users use to access your Revolut Kids & Teens account. These are separate apps. You cannot access the Revolut Kids & Teens app and Revolut Kids & Teens Users cannot access the Revolut app.

You can ask for a copy of these Revolut – Kids & Teens Terms through the Revolut app at any time.

2. What is Revolut - Kids & Teens?

Revolut – Kids & Teens is designed for parents who want their children to gain financial skills and to learn how to use and manage money. Your use of a Revolut – Kids & Teens account for any other purpose may breach the Revolut – Kids & Teens Terms.

As a Revolut – Kids & Teens account is a sub-account of your personal account, you are responsible for everything a Revolut – Kids & Teens User does using it as if you

had done it yourself.

The Revolut – Kids & Teens User can view any transactions made on their Revolut – Kids & Teens account using the Revolut – Kids & Teens app. You can also order a card linked to the account that they can use to spend and withdraw cash, subject to applicable fees as disclosed in the Cardholder Agreement. Revolut – Kids & Teens Users cannot make or receive transfers using the Revolut – Kids & Teens app except for transfers to or from other approved Revolut – Kids & Teens Users (the "Revolut – Kids & Teens Payments") as discussed in further detail in the Cardholder Agreement. You can move money into and out of the Revolut – Kids & Teens account from your Revolut personal account, keep track of how Revolut – Kids & Teens Users are spending that money, and control how Revolut – Kids & Teens Users can use their card using the Revolut app.

A Revolut – Kids & Teens account and card can only be used to spend the money you have moved to the Revolut – Kids & Teens account. If your Revolut – Kids & Teens User attempts a transaction using their Revolut – Kids & Teens card and there are not sufficient funds in the Revolut – Kids & Teens account, then the transaction will be declined, even if there are sufficient funds in your Revolut personal account.

3. Who can use a Revolut - Kids & Teens account?

You can create a Revolut – Kids & Teens account at any time in the Revolut app. When you do so, you must assign the Revolut – Kids & Teens User who you are giving access to the Revolut – Kids & Teens account. If we ask, you also must provide us with the information we need to verify the identity of the Revolut – Kids & Teens User. You can only give a person access as a Revolut – Kids & Teens User if they are aged between 6 and 17 and you are their parent, legal guardian, or otherwise have legal responsibility for them.

You can create more than one Revolut – Kids & Teens account. However, each Revolut – Kids & Teens account can only have one Revolut – Kids & Teens User linked to it, and the Revolut – Kids & Teens User you assigned to have access to the account cannot be changed.

4. Who is the legal owner of a Revolut – Kids & Teens account and card?

As a Revolut – Kids & Teens account is a sub-account of your Revolut personal account, you are the legal owner of it. You are responsible for everything a Revolut – Kids & Teens User does using your Revolut – Kids & Teens account as if you had done it yourself.

This includes any Revolut – Kids & Teens card. Each card issued for your Revolut – Kids & Teens account is issued to you and you authorize your Revolut – Kids & Teens

User to use it on your behalf. You are responsible for it and everything a Revolut – Kids & Teens User does using it as if you had done it yourself.

Although we provide you with tools to assist you to control your Revolut – Kids & Teens User's use of a Revolut – Kids & Teens account (like preventing ATM withdrawals or online purchases, and by adding or removing money), you remain responsible for that use.

Only you and we have rights under these Revolut – Kids & Teens Terms. Revolut – Kids & Teens Users do not. These Revolut – Kids & Teens Terms are personal to you and you cannot transfer any rights or obligations under it to anyone else.

5. What are your responsibilities?

As you are the Revolut – Kids & Teens account's legal owner, you are responsible for the Revolut – Kids & Teens account and all actions taken by your Revolut – Kids & Teens User(s). We do not accept any liability for how or where the Revolut – Kids & Teens card is used by your Revolut – Kids & Teens User.

You are also responsible for:

- explaining to your Revolut Kids & Teens User how to use your Revolut Kids & Teens account and card in line with these Revolut – Kids & Teens Terms (and must do so before they start using it).
- ensuring that your Revolut Kids & Teens User's use of your Revolut Kids &
 Teens account (for example, the things they buy with it) is acceptable to you.
- ensuring that you have agreed to your Revolut Kids & Teens User's use of the Revolut – Kids & Teens Payments feature (if applicable) by approving the first and all subsequent transfers to other Revolut – Kids & Teens users.
- making sure that the money in the Revolut Kids & Teens account is sufficient (but not excessive) for your Revolut – Kids & Teens User and in line with the account limits on your Revolut – Kids & Teens account.
- keeping your Revolut Kids & Teens cards and their PINs and details safe, and freezing and reporting them to us if they are lost or stolen.
- contacting us via your Revolut personal account to resolve any issues with or questions about the account (customer support is not offered in the Revolut – Kids & Teens app).

Remember, the rules on account and card use set out in the Personal Terms and the Cardholder Agreement apply to your Revolut – Kids & Teens account as well because it is a sub-account of your Revolut personal account. This means you are also responsible for ensuring that your use and your Revolut – Kids & Teens User's use of

your Revolut – Kids & Teens account is in line with those Personal Terms and the Cardholder Agreement.

6. Who can use a Revolut - Kids & Teens card and what for?

You can order one Revolut – Kids & Teens card for each Revolut – Kids & Teens User. In addition to the one Kids & Teens Physical Card, Revolut – Kids & Teens Users aged 13 and older may be eligible to request up to two (2) Kids & Teens Virtual Cards. The card(s), whether Physical or Virtual, must be used by, and only by, the Revolut – Kids & Teens User you have assigned to have access to the Revolut – Kids & Teens account.

The Revolut – Kids & Teens card can be used like any other card (on your Revolut personal account) to make purchases online or in person and to make ATM withdrawals, subject to the restrictions and limits discussed herein and in the Cardholder Agreement. You can turn on and turn off certain features and purchase types from the Revolut app.

To make the Revolut – Kids & Teens card as safe and secure as possible, we may block merchant types which we think are not age appropriate for Revolut – Kids & Teens Users. For example, merchants who only sell alcohol, cigarettes and gambling products. To do this, we rely on the merchant's registered business type (also known as an 'MCC code'), not the actual details of what is being bought on a Revolut – Kids & Teens card. This means Revolut – Kids & Teens cards are not restricted from, for example, buying alcohol at a supermarket (because the category of 'supermarket' is not restricted) or at a merchant with an inaccurate registered business type. If we turn a merchant off, you can't turn it back on.

7. Can I use Revolut – Kids & Teens in more than one currency?

You can only open and send money to a Revolut – Kids & Teens account in U.S. Dollars.

If you use a Revolut – Kids & Teens card to make a purchase in a currency other than U.S. Dollars, we'll perform a currency conversion in the same way as we would for a transaction on your Revolut personal account. See the Cardholder Agreement for additional details on limits and applicable fees.

8. Are there any fees or limits on a Revolut – Kids & Teens account?

There is no fee to create a Revolut – Kids & Teens account. The use of your Revolut – Kids & Teens account may be subject to additional fees and limits as disclosed in Revolut app. For a full listing of applicable fees and limits, see the Cardholder Agreement.

9. What happens if a Revolut – Kids & Teens account balance is negative?

Just like your Revolut personal account, Revolut – Kids & Teens accounts are not designed to have a negative balance. However, this can happen if, for example, because of an offline transaction.

When this happens, we will contact you to remediate the negative balance. If you do not remediate the negative balance promptly, we will transfer the amount of the negative balance from your Revolut personal account to your Revolut – Kids & Teens account. If this results in a negative balance on your Revolut personal account, our Personal Terms and the Cardholder Agreement will apply in the ordinary way.

10. How can a Revolut – Kids & Teens account or card be closed or canceled?

You can stop the use of a Revolut – Kids & Teens account at any time by:

- freezing or canceling the Revolut Kids & Teens card in the Revolut app; or
- withdrawing all of the money from the Revolut Kids & Teens card back to your Revolut personal account.

You can permanently close a Revolut – Kids & Teens account by canceling the Revolut – Kids & Teens account within the Revolut app, or by contacting us via in-app chat. Upon closure, any remaining money in the Revolut – Kids & Teens account will be returned to your Revolut personal account and the relevant Revolut – Kids & Teens Card will be canceled. Remember, the rules for account closure in our Personal Terms and the Cardholder Agreement also apply to your Revolut – Kids & Teens account.

11. What happens when a Revolut – Kids & Teens User turns 18?

When a Revolut – Kids & Teens User turns 18, they can continue to use the Revolut – Kids & Teens account for an additional 12 months, after which the Revolut – Kids & Teens account will be automatically closed and any remaining money in the Revolut – Kids & Teens account will be returned to your Revolut personal account. We won't issue any new card to a Revolut – Kids & Teens User who is over 18.

Once a Revolut – Kids & Teens User turns 18, they will be eligible to sign up for a Revolut personal account.

12. What happens if a Parent/Legal Guardian closes their Revolut personal account?

As a Revolut Account is a sub-account of a Parent's personal Revolut account, closing the personal Revolut account means the Revolut – Kids & Teens account will be closed too.

13. What happens if I move to another country?

If you plan to permanently move to another country, please contact us. You may need to provide us additional information so that we can determine if we can continue to offer you a Revolut – Kids & Teens account in that country. If we can't, your Revolut – Kids & Teens User account may need to be closed.

14. Permission for us to process your Revolut – Kids & TeensUser's personal information

To provide services under these Revolut – Kids & Teens Terms we need to obtain your verifiable consent and collect information from you, about your Revolut – Kids & Teens User. Under Children's Online Privacy Protection Rule ("COPPA"), we are what is known as the 'operators' of your child's personal information. For more information about how we use personal information generally, please see our Privacy Policy). By entering into these Revolut – Kids & Teens Terms, you are giving us permission to collect, use and store your Revolut – Kids & Teens User's personal information for the purpose of providing our services to you and them. This doesn't affect any rights and obligations you, your Revolut – Kids & Teens User, or we have under applicable laws including COPPA.

You can withdraw your permission to us processing your child's personal information by closing your Revolut – Kids & Teens account, which will end your agreement to the Revolut – Kids & Teens Terms between you and us. However, the Personal Terms and the Cardholder Agreement will remain in place between you and us, for your Revolut personal account.

If you end your agreement to these Revolut – Kids & Teens Terms, we'll stop using your Revolut – Kids & Teens User's information for the purpose of providing our services, but we may need to keep their information for other legal reasons.

15. Everything else

Remember, except as expressly modified in these Revolut – Kids & Teens Terms, our Personal Terms and the Cardholder Agreement apply to your use of the Revolut – Kids & Teens account and card. This means that all the rights you and we have under our Personal Terms and the Cardholder Agreement also apply to your use of the Revolut – Kids & Teens account and card. For this reason, you should read these Revolut – Kids & Teens Terms and our Personal Terms and the Cardholder Agreement together.
