

Stays Summer Campaign 2022

What is the promotion about?

This is a promotion where eligible customers can earn three cash giveaways a week for a period of four weeks by engaging with our posts on social media (the “**Promotion**”). Who is eligible, and how they engage is outlined below.

Who is eligible for the promotion?

Anyone who is a Revolut user in the United Kingdom or in Austria, Bulgaria, Cyprus, Estonia, Finland, France, Germany, Ireland, Latvia, Lithuania, Malta, Netherlands, Norway, Slovakia, Slovenia, and Spain is eligible for this promotion.

By “Revolut user” we mean someone who has completed our signup process, passed our onboarding checks, and has not had their account suspended, closed or restricted. If you are not already a Revolut user, you can sign up as a user and become eligible. It is free to sign up to our Standard plan.

How do I participate?

The Promotion will run for a period of four weeks, with three cash giveaways per week. The participation rules vary from week to week and can be found below.

To participate in Week 1, you must:

- Follow @revolutapp on Instagram
- Make a comment on the official Revolut Instagram post (from @revolutapp) inviting you to enter the Week 1 giveaway, which tags a friend’s Instagram handle and includes your Revtag

This promotion runs from 12:00pm BST on Friday 1 July 2022 to 12:00pm BST on Friday 8 July 2022. We call this the “**Week 1 Promotion Period**”.

To participate in Week 2, you must:

- Follow @revolutapp on Instagram
- Make a comment on the official Revolut Instagram post (from @revolutapp) inviting you to enter the Week 2 giveaway, which answers the question included in this post and includes your Revtag

This promotion runs from 12:00pm BST on Friday 8 July 2022 to 12:00pm BST on Friday 15 July 2022. We call this the **"Week 2 Promotion Period"**.

To participate in Week 3, you must

- Follow @revolutapp on Instagram
- Make a comment on the official Revolut Instagram post (from @revolutapp) inviting you to enter the Week 3 giveaway, which tells us your dream getaway destination and includes your Revtag

This promotion runs from 12:00pm BST on Friday 15 July 2022 to 12:00 BST on Friday 22 July 2022. We call this the **"Week 3 Promotion Period"**.

To participate in Week 4, you must

- Follow @revolutapp on Instagram
- Make a comment on the official Revolut Instagram post (from @revolutapp) inviting you to enter into the Week 4 giveaway, which tags two friends' Instagram handles and includes your Revtag

This promotion runs from 12:00pm BST on Friday 22 July 2022 to 11:59pm GMT on Friday 29 July 2022. We call this the **"Week 4 Promotion Period"**.

Duplicate comments will be counted as extra entries, so enter as many times if you like.

What's the cash giveaway, and how is the winner decided?

There are twelve cash giveaways, totalling £6,000:

- 3x £300 for Week 1
- 3x £400 for Week 2
- 3x £600 for Week 3
- 3x £700 for Week 4.

Revolut will select 12 individual users to win one cash giveaway each. Three winners will be selected at random from the comments on each of the four official Revolut Instagram posts published for this Promotion.

Winners will be notified via the official Revolut Instagram account and the cash amount will be paid into their Revolut account within two weeks of the end of the relevant week's Promotion Period. Payments will be converted from GBP to the base currency of the user's Revolut account.

What other legal information should I know?

In addition, the following terms and conditions apply to this promotion:
