

Revolut x Uber Promotion 2022

What is the promotion about?

Revolut is offering over 500 Uber vouchers valued at £15 each for use to Revolut customers in eligible markets who complete an international transfer of at least £200 or more.

This promotion will run **from 00:00 GMT on 6 December 2022 to 23:59 GMT on 21 December 2022**. We call this the **"Promotion Period"**.

What do I need to do to take part in the Promotion?

To be eligible for the Promotion you must:

- be a Revolut Ltd customer resident in England, Scotland or Wales (together the **"eligible markets"**);
- have an active Revolut Personal account (not suspended, closed or restricted); and
- receive an invitation to participate in the Promotion directly from us by email (if you have not received an email directly from us, you are not eligible).

You will also need to complete an international transfer of at least £200 or more through your Revolut Personal account during the Promotion Period.

To be considered valid, the transfer must be:

- an international transfer (domestic transfers in GBP, transfers made between Revolut users, and transfers in EUR to SEPA countries are not eligible); and
- completed (i.e. received by the payee's bank or payment account provider) before the end of the Promotion Period.

You must meet all the above criteria during the Promotion Period and comply with these terms to be eligible for the Promotion. If you do not, or if you only partially meet a criteria during the Promotion Period, you will not receive a Reward.

How do I receive my voucher?

Over 500 vouchers will be distributed to eligible users on a first-come, first-served basis. If you meet the eligibility criteria (the steps outlined in **"What do I need to do to take part in the Promotion?"** above), and we have not already distributed all of the vouchers, we will send you a voucher code. Each eligible customer is only entitled to receive one voucher code, regardless of how many qualifying transfers the customer has completed within the Promotion Period.

Voucher codes will be sent one day after the end of the Promotion Period (December 22nd 2022) via email. Each code will be valid for up to 36 months

You do not need to be an Uber customer to receive the voucher from us. Existing Uber customers are also eligible for the Promotion.

What other legal information should I know?

- For customers in England, Scotland, and Wales, this Promotion is organised and offered by Revolut Ltd, a company whose registered address is at 7 Westferry Circus, London, E14 4HD.

- We may, at our sole discretion, suspend, terminate or change these terms and conditions. If we exercise this right, we will try to give you advance notice.
- We may suspend or end the Promotion at any time if, in our reasonable opinion, the Promotion is being abused or may negatively affect Revolut's goodwill or reputation. We may do this on an individual or promotion wide basis.
- Events beyond the control of Revolut may also occur that render the awarding of the Uber voucher as part of this Promotion impossible. Revolut will not be liable for any loss, whether directly or indirectly suffered, as a result of an event outside of its control.
- If we have reasonable grounds to believe that you have engaged in any fraud or material abuse of this Promotion (such as for example attempting to obtain an unfair advantage through deception) we may in our sole discretion take any actions we see fit in the circumstances.

- These terms are published in English and any translation is a courtesy translation only. This means you cannot derive any rights from any translated version and only the English version can be used in legal proceedings.
- This promotion is governed by English law and the courts of England and Wales have exclusive jurisdiction to determine any dispute relating to it.
