

What is this Promotion about?

Revolut and TaxDown are offering existing Revolut Personal customers residing in Spain the opportunity to receive:

- **The TaxDown Free Offer:** The first 1,000 customers to open the unique link in the Communication will receive a subscription of the TaxDown Pro Plan at no cost, valid from the date of activation until 31 December 2026 (the **"TaxDown Free Offer"**).
- **The TaxDown Discount Offer:** All subsequent customers will receive a 40% discount on any TaxDown Plan (the **"TaxDown Discount Offer"**)

These terms and conditions (the **"Promotion Terms"**) set out the rules that apply to the Promotion, and you must comply with these Promotion Terms and also the [terms and conditions that apply to your Revolut Personal account](#) at all times when participating in the Promotion.

To take part in this Promotion, you must meet the eligibility criteria and complete the required steps set out in these Promotion Terms between **01/06/2026 (00:00 UTC) and 30/06/2026 (23:59 UTC)**. We call this the **"Promotion Period"**.

Who is eligible for this Promotion?

To be considered an **"Eligible Participant"** for this Promotion you must meet the following **"Eligibility Criteria"**:

- Have a residential address in Spain;
- Be at least 18 years old;
- Have an active Revolut Personal account (not closed, suspended, or restricted);
- Have received an email and/or push and/or see an in-app invitation from Revolut to participate in this promotion (the **"Communication"**); and
- Not having an active TaxDown subscription.

The required steps are :

1. **Access the link:** click on the unique link provided in the Promotion Communication you received to be redirected to the TaxDown landing page. A banner on the

landing page will clearly indicate whether you are among the first 1,000 customers and have secured the TaxDown Free Offer;

2. **Create an account:** create a TaxDown account by completing the TaxDown registration process
3. **Select a Plan:** choose your preferred TaxDown plan. Please note that if you are among the first 1,000, as indicated in the TaxDown landing page, you must select the TaxDown Pro Plan to receive the **TaxDown Free Offer**.
4. **Proceed to checkout:** proceed to checkout - the system will automatically determine your reward based on:
 - **a) The TaxDown Free Offer:** If you are among the first 1,000 customers (as indicated by the TaxDown landing page banner) and selected the Pro Plan, the TaxDown Free of Charge Offer will be automatically applied at checkout at no additional cost.
 - **b) The TaxDown Discount Offer:** If you are not among the first 1,000 customers (or if you selected a plan other than PRO), the 40% TaxDown Discount Offer will be automatically applied. **You must pay the remaining balance using your Revolut card or the IBAN of your Revolut Personal account.**

Please note: regardless of which offer you are eligible to, you must successfully complete the entire checkout process to secure your offer.

How do I start my TaxDown Free Offer?

If you are an existing Revolut customer and among the first 1,000 customers to access the unique link, and have completed the Required Steps within the Promotion Period, you will receive a TaxDown Pro Plan Free offer. Your TaxDown Free Offer will be valid from the date of activation until 31 December 2026. You must register with TaxDown through the unique link provided in the Communication received within the Promotion Period in order to get the TaxDown Free Offer.

The applicable terms and conditions of your selected TaxDown plan will apply to your account. Please ensure you are aware of the [terms and conditions](#) and any charges that may be applicable to your TaxDown account.

After the application of the TaxDown Free Offer, your TaxDown plan will automatically renew at the standard, non-discounted price. If you wish to continue using your TaxDown Plan, you will need to pay the relevant charges for the subscription to TaxDown in line with their terms and conditions.

Note: After the promotion period has ended on 31/12/2026, the user will be charged for the TaxDown Pro plan unless they cancel it beforehand. TaxDown will notify the user via e-mail that the promotion period for the TaxDown Free Offer will soon expire.

If the customer cancels their TaxDown subscription before 31/12/2026, then they will stop having access to the TaxDown Pro plan.

How do I start my TaxDown Discount Offer?

If you are an existing Revolut customer and have completed the Required Steps within the Promotion Period, you will receive a 40% discount on any Taxdown plan for the 2026 tax campaign.

You must register with TaxDown through the unique link provided in the Communication received within the Promotion Period in order to get the TaxDown Discount Offer.

The applicable terms and conditions of your selected TaxDown plan will apply to your account. Please ensure you are aware of the terms and conditions and any charges that are applicable to your TaxDown account.

After the application of the TaxDown Discount Offer, your TaxDown plan will automatically renew at the standard, non-discounted price. If you wish to continue using your TaxDown Plan, you will need to pay the relevant charges for the subscription to TaxDown in line with their terms and conditions.

Where possible, we will give notice through the app and/or email. Don't worry – if you've already taken part in the promotion, changes to the terms won't affect you unless reasonably unforeseeable circumstances outside of our control have made it impossible for us to run it.
Fraud or rule-breaking	If you breach the Revolut Personal Terms, these terms and conditions, or participate in the promotion fraudulently, we may cancel the the TaxDown Free Offer or the TaxDown Discount Offer. By proceeding, you authorise in advance any such cancellation.
Account closed or restricted	To receive the TaxDown Free Offer or the TaxDown Discount Offer, you must have an active Personal account (not closed, suspended, or restricted) throughout the Promotion Period and/or at the time you are due to receive the TaxDown Free Offer or the TaxDown Discount Offer.
Tax in Spain	If you are a resident of Spain, any prize is subject to Personal Income Tax. We are legally required to withhold 19% tax from your Prize before giving it to you. For your tax return, you must declare the Prize's total value (the advertised

	prize plus the 19% we withheld). You can then deduct the withheld amount from your tax liability.
Data & Privacy	We'll process your personal data in line with the Customer Privacy Notice that applies to your Revolut Personal account. TaxDown may also collect personal data about you in connection with this Promotion. See TaxDown's privacy notice for more details about how they will handle your personal data. TaxDown will also send any marketing content to you in compliance with applicable data privacy and direct electronic marketing laws. If you do not want to receive marketing from TaxDown you must manage your marketing preferences with TaxDown directly as this is outside of Revolut's remit.
Language	These terms and conditions are published in English and Spanish. The Spanish language version of these terms shall apply and prevail and be conclusive and binding. The Spanish version shall be used in any legal proceedings.
