

What is this Promotion about?

Revolut and TaxDown are offering prospective and existing Personal customers residing in Spain the opportunity to receive:

- A Cash reward of up to 75 EUR, (the **"Cash Award"**), according to the TaxDown Pro Plan subscription selected, for prospective Personal Revolut customers, if they open a Revolut Personal Account through the link provided by TaxDown;
- A TaxDown discount of 40% on any TaxDown Plan (the **"TaxDown Discount Offer"**) for the tax campaign 2026 for existing Personal customers, provided they do not already have an active TaxDown subscription.

These terms and conditions (the **"Promotion Terms"**) set out the rules that apply to the Promotion, and you must comply with these Promotion Terms and also the [terms and conditions](#) that apply to your Revolut Personal account at all times when participating in the Promotion.

To take part in this Promotion, you must meet the eligibility criteria and complete the required steps set out in these Promotion Terms between **25/03/2026 (00:00 UTC)** and **30/06/2026 (23:59 UTC)**. We call this the **"Promotion Period"**.

Who is eligible for this Promotion?

To be considered an **"Eligible Participant"** for this Promotion you must meet the following **"Eligibility Criteria"**:

- Have a residential address in Spain;
- Receive an email and/or push and/or see an in-app invitation from Revolut and/or receive an email and/or push and/or marketing from TaxDown, our selected **"Merchant Partner"** .

If you are a **new customer**, You need to complete the following **"Required Steps"** before the end of the Promotion Period:

Cash Award:

- **Open an account:** successfully open a Revolut Personal account for the first time (this means you cannot have or have previously held a Revolut Personal account with any Revolut Group entity) using the Promotion link provided by the Merchant Partner. This unique link will redirect you to Revolut's website where you will need

to provide your phone number in order to be directed to the sign up flow for a Revolut Personal account.

- **Pay for your TaxDown Pro plan** with your new Revolut card. This payment can be made using a physical or virtual Revolut card linked to your Revolut Personal account.

You must use the Promotion unique link provided as part of this Promotion to sign up for a Revolut Personal account. If you sign up using the normal account opening process in our app, you will not be able to benefit from the Cash Award.

If you are an **existing customer**, you need to complete the following required steps before the end of the promotion period:

TaxDown Discount Offer:

- access the discount through the Communication received;
- Click on link provided to be redirected to the TaxDown landing page;
- create a TaxDown account, by completing the TaxDown registration process;
- Pay for your selected TaxDown plan using your Revolut card or the IBAN of your Revolut Personal Account. The Taxdown Discount Offer will be automatically applied at checkout.

How do I get my Cash Award?

The Cash Award will be credited to your Revolut Personal account within 7 business days of the TaxDown Pro Plan subscription payment. The Cash Award will range between 35 - 75 EUR, covering the total cost of the TaxDown Pro Plan selected by the customer.

The TaxDown Plan Pro has 4 different price tiers, based on the user's tax situation:

- Essential - 35 euros
- Plus - 45 euros
- Autonomous - 49 euros
- Investor - 75 euros

How do I start my TaxDown Discount Offer?

If you are an existing Revolut customer and have completed the Required Steps within the Promotion Period, you will receive a 40% discount on any Taxdown plan for the

2026 tax campaign.

You must register with TaxDown through the unique link provided in the Communication received within the Promotion Period in order to get the TaxDown Discount Offer.

The applicable terms and conditions of your selected TaxDown plan will apply to your account. Please ensure you are aware of the terms and conditions and any charges that are applicable to your TaxDown account.

After the application of the TaxDown Discount Offer, your TaxDown plan will automatically renew at the standard, non-discounted price. If you wish to continue using your TaxDown Plan, you will need to pay the relevant charges for the subscription to TaxDown in line with their terms and conditions.

What other legal information should I know?

1. We may change, suspend or end the Promotion earlier than the end date we've mentioned above if, in our reasonable opinion, the Promotion is being abused or may negatively affect Revolut's goodwill or reputation. We may do this on an individual or promotion-wide basis.
2. If we need to change, suspend or end the Promotion before the end of the Promotion Period, we will announce this in the same way the Promotion was announced and, where possible, we will give you notice through an email, push notification and/or in-app Inbox message. Any changes to the Promotion Terms will not affect your rights, if you have already participated in the Promotion.
3. Revolut will not be liable for any loss, whether directly or indirectly suffered, as a result of an event outside of its control which means we are unable to continue running the Promotion as planned. Please contact Support if you believe you qualify for a particular benefit in relation to the Promotion that has not been awarded to you as a result of early suspension or termination.
4. We reserve the right to reverse the Cash Award during the Promotion Period if the payment that earned you the Cash Award is refunded to you, you earned the Cash Award fraudulently, if you breach the terms that apply to your Revolut Personal account in order to get the Cash Award, or if we become aware you were not compliant with these Promotion Terms. We will consider the reversal of any Cash Award to have been done with your consent and the payment to have been authorised by you.

5. If you close your Revolut Personal account or your account becomes suspended or restricted before we were due to credit your account with the Cash Award or between the time of qualifying for the Cash Award and receiving it, you will lose your entitlement to it.
6. Revolut needs to process your personal data to perform our obligations under these Promotion Terms. For more information about how we handle personal data, see our [Customer Privacy Notice](#). TaxDown may also collect personal data about you in connection with this Promotion. See [TaxDown's privacy notice](#) for more details about how they will handle your personal data. TaxDown will also send any marketing content to you in compliance with applicable data privacy and direct electronic marketing laws. If you do not want to receive marketing from TaxDown you must manage your marketing preferences with TaxDown directly as this is outside of Revolut's remit.
7. These terms are published in Spanish and any translation is a courtesy and an unofficial translation only. Participants of the Promotion cannot derive any rights from the translated version. The Spanish language version of these terms shall apply and prevail and be conclusive and binding. The Spanish version shall be used in any legal proceedings. If, however, by law the local language should be used, the local language shall prevail.
8. This Promotion is organised and offered to you by Revolut Bank UAB, Sucursal en España, with tax ID W0250845E, duly registered with the Commercial Registry in Madrid under Volume 44863, Sheet 1, Section 8, Page M-789831 and with the Bank of Spain under number 1583. Its address is at Príncipe de Vergara 134, 4 planta, 28002, Madrid (Spain). If you have a complaint about this Promotion, you can raise it directly with them.
9. The law applicable to these Promotion T&Cs is the Spanish one and the Courts with jurisdiction to deal with any claim are the Spanish ones.
10. Please note that any payment under this Promotion is subject to IRPF as income from movable capital subject to withholding tax (in accordance with the applicable legislation and without prejudice to the provisions of the provincial tax regimes). You, when receiving such payments, must declare a yield of movable capital in your savings taxable base determined by the full amount received, and you can deduct from the tax liability the withholding on account practiced. The total amount of the payment will be the amount communicated in the promotion invitation received in the app plus the amount of tax that we are obliged to withhold. A 19% income tax withholding is made on this amount, which results in the net amount paid.
