

## What is this Promotion about?

Revolut and TaxDown are offering Revolut prospective Personal customers residing in Spain the opportunity to receive a cash reward of up to 75 EUR, (the "**Cash Award**") if they open a Revolut Personal Account through the link provided by TaxDown.

The Cash Award rewarded will range between 35 - 75 EUR, covering the total cost of the PRO Plan in TaxDown for each customer.

These terms and conditions (the "**Promotion Terms**") set out the rules that apply to the Promotion, and you must comply with these Promotion Terms and also the [Terms and Conditions](#) that apply to your Revolut Personal account at all times when participating in the Promotion.

To take part in this Promotion, you must meet the eligibility criteria and complete the required steps set out in these Promotion Terms between **05/05/2025 (00:00 UTC)** and **30/06/2025 (23:59 UTC)**. We call this the "**Promotion Period**".

## Who is eligible for this Promotion?

To be considered an "**Eligible Participant**" for this Promotion you **must** meet the following "**Eligibility Criteria**":

- have a residential address in Spain;
- not have or have previously held a Revolut Personal account with any Revolut group entity;
- receive an email and/or push and/or marketing from TaxDown, our selected "**Merchant Partner**".

You will also need to complete the "**Required Steps**" before the end of the Promotion Period:

- **Click on the unique link** provided by the Merchant Partner. This **unique link** will redirect you to Revolut's website where you will need to provide your phone number in order to be directed to the sign up flow for a Revolut Personal account.
- **Successfully open a Revolut Personal account** for the first time through the Promotion unique link or QR code

- **Purchase a PRO Plan in TaxDown** with your Revolut card and put your Revolut IBAN as the account where tax payment or return should be sent to.

You must use the Promotion unique link provided as part of this Promotion to sign up for a Revolut Personal account. If you sign up using the normal account opening process in our app, you will not be able to benefit from the Cash Award.

The Cash Award rewarded will range between 35 - 75 EUR, according to the total cost of the PRO Plan in TaxDown for each customer.

Your PRO Plan in TaxDown purchase can be made using a physical or virtual Revolut card linked to your Revolut Personal account.

## How do I get my Cash Award?

The Cash Award will be credited to your Revolut Personal account within 7 business days of your PRO Plan in TaxDown purchase completed. The Cash Award will be up to 75 EURO. This Promotion is not cumulative to any other promotion offered either by Revolut or TaxDown.

## What other legal information should I know?

1. We may change, suspend or end the Promotion earlier than the end date we've mentioned above if, in our reasonable opinion, the Promotion is being abused or may negatively affect Revolut's goodwill or reputation. We may do this on an individual or promotion-wide basis.
2. If we need to change, suspend or end the Promotion before the end of the Promotion Period, we will announce this in the same way the Promotion was announced and, where possible, we will give you notice through an email, push notification and/or in-app Inbox message. Any changes to the Promotion Terms will not affect your rights, if you have already participated in the Promotion.
3. Revolut will not be liable for any loss, whether directly or indirectly suffered, as a result of an event outside of its control which means we are unable to continue running the Promotion as planned. Please contact Support if you believe you qualify for a particular benefit in relation to the Promotion that has not been awarded to you as a result of early suspension or termination.
4. We reserve the right to reverse the Cash Award during the Promotion Period if the payment that earned you the Cash Award is refunded to you, you earned the Cash

Award fraudulently, if you breach the terms that apply to your Revolut Personal account in order to get the Cash Award, or if we become aware you were not compliant with these Promotion Terms. We will consider the reversal of any Cash Award to have been done with your consent and the payment to have been authorised by you.

5. If you close your Revolut Personal account or your account becomes suspended or restricted before we were due to credit your account with the Cash Award or between the time of qualifying for the Cash Award and receiving it, you will lose your entitlement to it.
6. Revolut needs to process your personal data to perform our obligations under these Promotion Terms. For more information about how we handle personal data, see our [Customer Privacy Notice](#). TaxDown may also collect personal data about you in connection with this Promotion. See TaxDown's [privacy notice](#) for more details about how they will handle your personal data. TaxDown will also send any marketing content to you in compliance with applicable data privacy and direct electronic marketing laws. If you do not want to receive marketing from TaxDown you must manage your marketing preferences with TaxDown directly as this is outside of Revolut's remit.
7. These terms are published in Spanish and any translation is a courtesy and an unofficial translation only. Participants of the Promotion cannot derive any rights from the translated version. The Spanish language version of these terms shall apply and prevail and be conclusive and binding. The Spanish version shall be used in any legal proceedings. If, however, by law the local language should be used, the local language shall prevail.
8. Please note that any payment under this Promotion is subject to IRPF as income from movable capital and might be subject to withholding tax (in accordance with the applicable legislation and without prejudice to the provisions of the provincial tax regimes). You, when receiving such payments, must declare a yield of movable capital in your savings taxable base determined by the full amount received, and you can deduct from the tax liability the withholding on account if it has been practised. The total amount of the payment will be the amount communicated in the promotion invitation received in the app plus the amount of tax that we are obliged to withhold. A 19% income tax withholding is made on this amount, which results in the net amount paid.
