## **Restricted Products and Supported Visas**

Depending on the information you provide to Revolut, your access to certain Revolut products and features may be limited. If you do not or are unable to provide a tax identification such as a Social Security Number (SSN) or U.S. Individual Taxpayer Identification Number (ITIN), you will not be able to access the full suite of Revolut products. A U.S. tax identification is required for certain products such as Stocks, Crypto, Savings Vaults (FDIC Insured), Credit Cards, Personal Loans, Premium and Metal plans, so you will not be able to use these features upon opening an account without an SSN or ITIN.

If you obtain an SSN/ITIN after opening a Revolut account, you can submit it in the Revolut app to access more products. Your access to additional products will remain restricted until Revolut is able to successfully verify your SSN/ITIN. Please reach out to us via in-app chat with any questions about updating your SSN/ITIN information.

If you don't provide an SSN/ITIN when opening a Revolut account, you will be requested to provide additional documentation such as a valid US visa to verify your identity.
