1. What's in these terms?

These terms tell you the rules for using our website www.revolut.com (our site).

2. Who we are and how to contact us?

Our site is operated by Revolut Technologies Singapore Pte. Ltd. (we or us). We are registered in Singapore under company number 201721013G and have our registered office at 30 Cecil Street #19-08, Prudential Tower, Singapore 049712.

We are regulated by the Monetary Authority of Singapore ("MAS") as a Major Payment Institution under the Payment Services Act (No.2 of 2019) to carry on the business of providing Account Issuance Service, Domestic Money Transfer Service, Cross-border Money Transfer Service and E-money Issuance Service. As a regulated entity, we are required to comply with all applicable laws, regulations, notices and guidelines issued by the relevant government and regulatory authority. Use of the website

3. By using our site you accept these terms

By using our site, you confirm that you accept these terms of use and that you agree to comply with them. If you do not agree to these terms, you must not use our site. We recommend that you print a copy of these terms for future reference.
