

## What is this Promotion about?

- **What:** Select Revolut Business customers who add new Titan Users will have the monthly RevPoints cap (usually 10K monthly) removed for up to 3 months for these Titan Users (the **Promotion**), limited to the first 3000 Titan sign ups.
- **Who:** Eligible Participants who reside in the United Kingdom (the **UK**) and complete the Required Step set out below.
- **When:** This Promotion is limited to the first 3000 Titan User sign-ups between **22 July 2026, 00:00 BST to 31 August 2026, 23:59 BST** (the **Sign-up Period**).

**Important:** Titan Users can benefit from up to 3 months of uncapped RevPoints from **22 July 2026, 00:00 BST to 30 November 2026, 23:59 BST** (the Promotion Period).
