The basics

1. What's in these terms?

These terms tell you the rules for using our website www.revolut.com/en-AU (our site).

References to "you" means an individual authorised to use our website in connection with our products or services, or inquiring into using our products or services.

2. Who we are and how to contact us?

Our site is operated in Australia by Revolut Payments Australia Pty Ltd (ACN 634 823 180), AFSL and Australian Credit Licence no. 517589 (**we, us, our**). We are registered in Australia and have our office located at Level 28, 161 Castlereagh Street, Sydney, NSW, 2000 Australia. Use of the website

3. By using our site you accept these terms

By using our site, you confirm that you accept these terms of use and that you agree to comply with them.

If you do not agree to these terms, you must not use our site.

4. There are other terms that may apply to you

These terms of use refer to the following additional terms, which also apply to your use of our site:

- Our Privacy Policy, which sets out the terms on which we collect and process any personal information. By using our site, you consent to such collection and processing and you warrant that all information provided by you is accurate.
- Our Cookie Policy, which sets out information about the cookies on our site.

5. Credit score service

13.1 Limitations of liability that apply to our products

Personal Accounts
