

What is this Promotion about?

- **What:** earn a cash reward of 250 SEK (the **Welcome Bonus**) and be entered into a prize draw (the **Prize Draw**) for a chance to participate in the associated influencer's youtube video (the **Prize**).
- **Who:** existing and new Revolut Personal customers residing in Sweden who complete the Required Steps below.
- **When:** The promotion will be available only for the time period specified in the promotion's landing page (the **Promotion Period**). You must complete the Required Steps before the end of the Promotion Period.

Only new Revolut customers are eligible for the Welcome Bonus. Both new and existing Revolut customers are eligible for the Prize Draw.

These **Promotion Terms** set out the rules that apply to this promotion. You must comply with these Promotion Terms as well as the [Personal Terms](#) that apply to your Revolut Personal account.

Eligibility and required steps

To be an **Eligible Participant** for this promotion, you **must**:

- have a registered address in Sweden,
- if you're a new Revolut customer, not have or have previously held a Revolut Personal account with any Revolut Group entity;
- if you're an existing Revolut customer, be an active Revolut Personal customer with no restrictions on your account,
- have received an email, social media post or in-app communication inviting you to participate in this promotion (the **Promotion Invitation**), and
- be at least 18 years old.

The **Required Steps** are:

1. **Click on the unique link for the Promotion.** This link will be on the associated influencer chosen channels;
2. **If you're a new Revolut customer, follow the unique link for the Promotion and successfully open a Revolut Personal account**, completing our Know Your

Customer (**KYC**) checks before the end of the Promotion Period. If you open an account using the normal account opening process in our App, without using the unique Promotion link, you won't be eligible to participate in this promotion; and

3. Only for the Welcome Bonus: make a single card payment of at least 0,01 SEK.

Your first card payment can be made using a physical or virtual Revolut card linked to your Revolut Personal account. It must be a genuine purchase (for example, transactions to payment service providers, other bank accounts, e-wallets, gambling service providers, or the purchase of gift cards or currency do not count as genuine).

If you are an Eligible Participant and complete steps 1 and 2, but do not complete step 3, you will still be eligible for the Prize Draw.

When do I get the Welcome Bonus?

We'll credit the Welcome Bonus to your new Revolut personal account within **30 calendar days** of you completing the Required Steps above.

How does my entry to the Prize Draw work?

Within **5 business days** after the end of the Promotion Period, we'll randomly select the winners from all Eligible Participants who have completed the Required Steps 1 and 2 (a card payment under step 3 is not required to enter the Prize Draw).

If you're a winner, we'll let you know via the email address registered to your Personal account. You'll have 2 business days from the time we contact you to accept the Prize and provide us with any requested information. If you don't respond to us within this time, your entry will be void and we'll randomly select another winner.

If we realise you're no longer eligible for this promotion after we have contacted you, we won't be able to give you the Prize, and will randomly select another winner.

The Prize does not include any costs related to travel, accommodation, or other expenses in attending the event. If you win, you'll be responsible for such costs.

Changes or early end	If the promotion changes or ends early but has not been withdrawn, we will tell you this in the same way we invited you to the promotion (e.g. email, push notification, in-app). Where possible, we will give notice through the Revolut app and/or email. Don't worry – if you've already taken part in the promotion, changes to the terms and conditions won't affect you unless reasonably unforeseeable circumstances outside of our control have made it impossible for us to run it.
Fraud or rule-breaking	If you breach the Revolut Personal Terms, these terms and conditions, or participate in the promotion fraudulently, we may reverse any Welcome Bonus credited to your account and/or disqualify you from the Prize Draw. By proceeding, you authorise in advance any such reversal.

The final video will be published on YouTube. You acknowledge that the Prize involves taking part in an influencer's youtube video, which will involve being filmed and the recordings of you being published online. Revolut is not responsible for the collection or use of such recordings by the influencer. If you change your mind and no longer wish to claim the Prize, you can always let us know and we will select another winner.
Exclusions	Employees, directors, agents, contractors and affiliates of Revolut group entities are not eligible for this promotion.
